## 2020 Annual Shareholders Meeting

Total Assets, up 1.7%

Revenue, up 3.1%

Net Income totals \$326,000

Mr. Logan stated that the NCUA successfully completed their audit in 2019. Mr. Logan also discussed the Supervisory Committee and their role as well as the appointment of Peter Atwell as the Supervisory Chair in the summer of 2019.
